"Gold" corporate members will also be identified in the WIIT Membership brochure and in the "Corporate Members" section at the front of the WIIT directory.

The CAB meets twice a year with representatives of the WIIT Board and the WIIT President and serves as a general sounding board for ideas pertaining to substantive programs, professional development programs, activities, and membership services.
